NCA Presidential Initiative: Founded NCA Anti-Bullying Project— The NCA Anti-Bullying Project began with the goals of (a) facilitating Communication-based contributions to addressing the serious societal problem of bullying and (b) encouraging collaborations among Communication scholars from across our discipline. Since 2014, this project has resulted in the establishment of the NCA Anti-Bullying Resource Bank (available to stakeholders within and beyond the academy) and the appointment of the NCA Anti-Bullying Task Force. Since 2015, we have hosted four NCA Anti-Bullying Roundtable Discussions during the NCA annual convention that have resulted in short courses, pre-conferences, research collaborations, and the publication of the award-winning Routledge Handbook of Communication and Bullying.
