Vice President Scott Moody announced that the speaker for March will be **Dr. Gillian Ice**. Dr. Ice, professor of social medicine at the Heritage College of Osteopathic Medicine, has served as the special assistant to the president for public health operations at Ohio University. In that role, Ice has overseen nonclinical case management, has coordinated the University's response to positive COVID-19 cases, and acted as a point of contact for sharing information about public health initiatives with the University community. In addition, Ice also monitored public health data in the counties where Ohio University has campuses and other business operations and acted as a liaison to regional campus teams.

Ice teaches in a number of areas including research methods and evidence-based medicine, epidemiology, geriatrics, cultural competence, and global health. She is currently working on several health systems strengthening projects in Rwanda, Ethiopia, and Botswana that includes research training and capacity building. She was PI and director of the Fulbright Junior Faculty Development Program in Public Health called Egypt @OHIO. More information on Dr. Ice can be found at this link.

### **Notes from the March 17 Emeriti Meeting**



Corinne Colbert, former Editor of the Athens News, highlighted the state of newspaper publishing and especially the coverage of local news in her presentation to the Emeriti. Colbert noted that the US now has only as many newspapers as it did in 1835 when the country had a much smaller population.

She noted that her firing as editor of the Athens News is emblematic of the current issues happening to newspapers in America today. The current impact of consolidation on local Athens coverage is the reduction of staff to very minimal levels at minimal expense. For the Athens News, that amounted to one editor and one reporter to cover all of Athens County, down from a staff of about eight including three free-lancers at the time the paper was purchased by its current owner, Adams Publishing Group (APG), as one of its 170 newspapers. APG also owns the Athens Messenger.

Colbert reviewed the impact of the consolidation of newspapers to large chain ownership as started by E.W. Scripps in 1894. By 1935, chains controlled about half of American daily newspapers, using central editing and syndicated information for a larger proportion of the content. By 1995, chain ownership was about 80% of newspapers. Today, the vast majority of daily newspapers are owned by three major companies, two of which are hedge funds. The shift to advertising on the internet has also heavily impacted newspapers.

Colbert said journalism's first responsibility is to the truth, and its first loyalty is to the readers. The loss of or reduction in local newspapers has led to lower voter turnout, fewer candidates running for local office, increased government corruption, and increased partisanship, all of which are exacerbating an erosion in our democracy.

Colbert received a round of applause on announcing that she and some of her colleagues are starting their own local newspaper, *The Athens County Independent*.
