The four current markers are for:


Booker T. Washington - Olivia Davidson wedding site marker – Washington Street, Athens

Milton Holland marker – Athens County Fairgrounds, the site where in 1863 he raised Company C of the 5th United States Colored Infantry

The boyhood home of Albion Tourgée, author, Civil War soldier, lead attorney for Homer Plessy in Plessy v. Ferguson, who coined the expression "color-blind justice," – Ohio Rt. 193, Kingsville


The "Chauncey Boys" marker honoring three Civil War Patriots — Dover Township Park, Chauncey.

A proposed marker for Charles C. McCabe, Civil War chaplain and Presbyterian minister, said to be the major "popularizer" of the "Battle Hymn of the Republic" for the front of Tupper Hall near where his birthplace and boyhood home once stood.
